

BLACK PANER PARTY, akå Black Panther Party for Self Defense

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1986, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by Bobby George Seale, BPP Chairman, and Hugy P. Newton, BPP Minister of Defense. Newton is precently serving a sentence of 2 to 15 years on a conviction of manslaught in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and genrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "...we will not dissent from American Government. We will overthrow it.", #

Issues of "The Black Panther" regularly contain quotatic from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3103 Shattuck Avenue, Berkeley, California. Branches have been cotablished at various locations throughout the United States.

A source has advised that the Students for a Democratic Society (SDS), as presently regarded, came into being at a founding convention held June, 1962, at Port Huron, Michigan. From an initial posture of "participatory democracy" the line of the national leadership has revealed a growing Marxist-Leninist adherence which currently calls for the building of a revolutionary youth movement. Concurrently, the program of SDS has evolved from civil rights struggles to an anti-Vietnam war stance to an advocacy of a militant anti-imperialist position. China, Vietnam and Cuba are regarded as the leaders of worldwide struggles against United States imperialism whereas the Soviet Union is held to be revisionist and also imperialist.

At the June, 1969, SDS National Convention, Progressive Labor Party (PLP) forces in the organization were expelled. As a result, the National Office (NO) group maintained its National Headquarters at 1608 West Madison Street, Chicago, and the PLP faction set up headquarters in Cambridge, Massachusetts. This headquarters subsequently moved to Boston. Each group elected its own national officers, which include three national secretaries and a National Interim Committee of eight. Both the NO forces and the PLP forces claim to be the true SDS. Both groups also print their versions of "New Left Notes" which sets forth the line and the program of the particular faction. The NO version of "New Left Notes" was recently, printed under the title "The Fire Next Time" to achieve a broader mass appeal.

Two major factions have developed internally within the NO group, namely, the Weatherman or Revolutionary Youth Movement (RYM) I faction, and the RYM II faction. Weatherman is action-oriented upholding Castro's position that the duty of revolutionaries is to make revolution. Weatherman is regarded by RYM II as an adventuristic, APPENDIX

elitist faction which denies the historical role of the working class as the base for revolution. RYM II maintains that revolution, although desired, is not possible under present conditions, hence emphasizes organizing and raising the political consciousness of the working class upon whom they feel successful revolution depends. Although disclaiming control and domination by the Communist Party, USA, leaders in these two factions have in the past proclaimed themselves to be communists and to follow the precepts of a Marxist-Leninist philosophy, along pro-Chinese communist lines.

A second source has advised that the PLP faction which is more commonly known as the Worker Student Alliance is dominated and controlled by members of the PLP, who are required to identify themselves with the pro-Chinese Marxist-Leninist philosophy of the PLP. They advocate that an alliance between workers and students is vital to the bringing about of a revolution in the United States.

SDS regions and university and college chapters, although operating under the outlines of the SDS National Constitution, are autonomous in nature and free to carry out independent policy reflective of local conditions. Because of this autonomy internal struggles reflecting the major factional interests of SDS have occurred at the chapter level since the beginning of the 1969-70 school year.

PROGRESSIVE LABOR PARTY.

The "New York Times" city Sition Taesday, April 20, 1935, page 27, reported that a new party of "revolutionary socializan" was formally founded on April 18, 1965, under the name of the PLP, which had been known as the Progressive Labor Movement.

According to the article, "The Progressive Labor Movement was founded in 1932, by Ellton Rosen and Mortimer Scheer after they were expelled from the Communist Party of the United States for accertedly following the Chinese Communist line."

A source advised on June 5, 1968, that the PLF held its Second National Convention in New York City May 31 to June 2, 1968, at which time the PLP reasserted its objective of the establishment of a militant working class movement based on Marxism-Leninism. This is to be accomplished through the Party's overall revolutionary strategy of raising the consciousness of the people and helping to provide ideological leaderchip in the working class struggle for state power.

The source also advised that at the Second National Convention Milton Fosen was unanimously re-elected National Chairman of the PLP and Levi Laub, Fred Jerome, Jared Israel, William Epton, Jacob Rosen, Jeffrey Gordon and Walter Linder were elected as the National Committee to lead the PLP until the next convention.

The PLP publishes "Progressive Labor," a bimonthly magazine; World Revolution," a quarterly periodical; and "Challenge-Desafio," a monthly newspaper.

The August, 1968, issue of "Challenge-Desafio" sets forth that "above all, this paper is dedicated to the fight for a new way of lifewhere the working men and women own and control their homes, factories, the police, courts, and the entire Government on every level."

The source advised on June 3, 1968, that the PLP utilizes an address of General Post Office Box 808, Brochlyn, Hew York, and also utilizes an office in Rosa 317, 1 Upion Supero Wost, New York, 1947 York.

"The shooting of an American soldier last week in San Juan was attributed to revenge for the assassination of the young student, Antonia Martinez," according to a clandestine communication result in the press of this country. If it is the that it is an action on the part of clandestine independence groups, it is obvious that this represents an escalation in that type of struggle. It is important that we analyze at this time the possible implication of this act of war to better understand our national destiny.

"In the first place, it is not - as a superficial view of the problem would indicate the matter of a murder in answer to another one. There can be no comparison between Antonia Martinez and the American sailor, except that they are both human beings who were killed by violent means. Of course, any violent death makes us feel sorry. But it is necessary to make a distinction. It is one thing for a young lady to be assassinated in her own country as a result of the brutal repression of the regime against the university students. But, the death of a young man, who was part of the "Inveding armed forces in an occupied country by those who are at war against the occupiers of their country, is another thing. The job of soldiers and sailors is to kill. They run the risk of dying. Those who join the Yankee Armed Forces are willing to kill Vietnamese, Dominicans or Puerto Ricans in order to serve the imperialist establishment which the army and navy support by force. It is understood, therefore, that he (the serviceman) assumes the came risk of those whom he is willing to kill, i.e., to be killed by them. That is the logic of war.

"We have publicly acknowledged that in Fuerto Ricc there is an incipient armed struggle on the part of pro-independence individuals, who consider



it their patriotic duty to conduct warfare against the empire which dominates us. We believe that every Flerto Rican has the right to make war against the invalers of our country. And war is mainly killing and dying.

"In the Folitical Thesis of the MPI, in an analysis of the growing repression against independence feeling in Puerto Pico, we have pointed out as an objective conclusion that the clandestine and armed struggle will increase in the same proportion as the regime drowns the legal area in which the independence movement functions.

"What happened last week is a clear indication of the correctness of our political thesis with regard to this conclusion.

"Until now, the actions of the clandestine groups had been limited to attacking the property of Yankoe interests and the property of the Government of the United States. Going from the destruction of property to the killing of American soldiers is no doubt nearing a war which, if continued, would radically transform the national scene. What factor has caused this further step in the armed struggle? It is legical that the factor is, as the clandestine communication indicates, the assassination of the young university student. It is reasonable to conclude that those, who have made up their mind to conduct warfare against the invading regime, chose as the correct time for this act of war the historical moment when the regime increased its repression to the extent of murder.

"If this acceleration in the armed struggle induces the regime to increase its repression, the time will come when warfare will be the only alternative for the Puerto Rican patriotic forces.

Fecause one thing is clear: repression cannot be exerted against those engaged in the clandeatine struggle, as they are very careful not to come within the grasp of the repressive apparatus of the regime. Pepression is exerted against the proindependence followers who operate in the open. And this persecution necessarily transforms the nature of our struggle, making it more radical, both ideologically and tactically.

"If Fuerto Rico is to obtain independence without fill scale war, it is to be mainly determined by the regime. No country prefers the violence of war Ect ro self-respecting country lays down passively to the violence of the enemy. The enemies of Fueric Fico should have this made very clear, as the alternative is again proposed to them."

A transcript of the questions and answers of this news interview follows:

Do you feel that the 18 year old mote, if granted, will help the independence cause in Puerto Rico in any way?

I believe the idea is part of a general plan in the United States to stop the great impulse of the youth at this time; it is a concertion which recognizes the political importance of that youth in the shaping of a new society and if the 18 year old vote is granted, it will definitely help the Fuerto Rican Independence Movement.

Am I right in assuming that you would oppose it because it would be harmful to organizations such as yours in that it would channel the energy of youngpeople in another direction?

No, I do not visualize the problem in that way: I would insist that youth develop its action in all possible fronts and that they not be restricted to the vote only.

No, I do not consider myself a communist.

 - I believe in Socialism and I believe in National Liberation as the essential drive for the Puerto Rican people.
- 2-5 As the Secretary General of one of the more militant independence groups in the island, what is your position on the various island confrontations in the universities here and on the mainland also?
 - I think it is the repression of the establishment that brings this rebellion of youth that wants to be heard and that wants to participate in all the problems, national and internationally, and again it is the repression that brings the rebellion.
- Q-6 Mr. Mari Bras, supposing that you became President of Puerto Rico one day, what kind of changes would you like to see occur in the political and economic structure of Puerto Rico?

Regardless of who is the president, which is a secondary matter in which we are not interested, we would like to see some basic changes come about. That would be gaining again for the people of Puer to Rico the material basic for economic development and having the people organize and select its own destiny in any way they desire without any intervention from any outside power.

Q-7 Mr. Mari Bras, does this mean expropiation of American firms operating in Puerto Rico?

Yes, definitely.

- Q-8 What will be the impact of this in the Puerto Rican economy when 90% of the capital invested in Puerto Rico is American capital; would that adversely affect the economy?
 - On the contrary, it would be definitely positive if 90% of our riches - is alienated from our people. Now, if you could get that riches in our hands it would be a lot better for the development of our own people.

Would you consider any kind of investment at all either United States or European or Japanese?

We do not believe in capital investment as a way of development. We believe in commerce and in credit in foreign markets so as to develop our own economy. It has been proved that the capital investment is an agent for bringing profits out of countries instead of developing countries.

Mr. Mari Bras, you have said repeatedly that you believe that political forces in Puerto Rico are becoming polarized, the forces toward statehood and the forces toward independence. In terms of

the 1972 elections, do you visualize then the disappearance or the virtual disappearance of the Popular Democratic Party as a major force in Puerto Rico?

We do not visualize the disappearance of the Popular Democratic Party, but we do see the disappearing of those forces which are seeking compromise as in the Commonwealth Status.

- Q-11 Would you say then that in terms of electoral politics in Puerto Rico, beginning with 1972, it will be largely a statehood government in the Executive and also the Legislature?
 - It all depends on the development of events in the next few months and years. Who knows if the Ferre Government will get to 1972; it could collapse by all the mishandling of government. It would not be the first time that a government does not finish its mendate.
- Q-12 Mr. Mari, then if the Ferre Government should possibly collapse and if the so called autonomous forces in Puerto Rico are moing to be dramatically reduced, do you see the possibility that in 1972 the Puerto Rican interpendence Party may emerge as a very strong party?
 - Definitely, the Puerto Rican Independence Party is one of the principal forces in the electoral politics of the country. It is the only party that presents a growth.
- Q-13 If Ferre's party does fall from power and the Puerto Rican Independence Party gainz some legislative gains in the 1972 elections, will there be cooperation between the PIP and the MPI?

Regardless of whether they have or don't have legislative representation, our policy of national unity is such that we will cooperate with the PIP in all matters and in common actions towards objectives which are common to both organizations.

Q-14 Sir, again, more specifically to your own activities, the Associated Press reported your activities where you were apparently attempting to visit representatives of North Vietnam to see if a political prisoner # exchange could be worked out between the United States for five Puerto Rican Nationalists jailed in the United States and for other prisoners being held in North Vietnam. Did you indeed engage in this?

Yes. we made such a request to the Democratic Republic of Vietnam and later visited the North Vietnam delegation in Paris. Our proposal was discussed and we received assurances that it would be considered by the government of North Vietnam.

Q-15 Are you aware, Sir, that there is a Federal law against such action? Are you aware that you broke such a law?

I am not interested whether it is legal or illegal in the United States' sense of it. I proceed as my most authentic sense of being Puerto Rican forces me to.

Q-16 Mr. Mari Bras, you mentioned before that the Ferre adminstration may collapse before 1972. Will you please be more explicit? Do you foresee a possible revolution before 1972?

i will not discard the possibility of it being before 1972, but I would say it is not probable. However, I do say that there is going to be a revolution in this country, that there will be a revolutionary process in Puerto Rico.

-17. Do you feel the revolution might come during 1970 or the decade of the 70's?

'It is probable.

What do you mean by act of terrorism?

Q-20 ____ Acts of terrorism and destruction perpetrated against mainly mainland businesses that were later claimed by various terrorist groups. To be more specific, the recent Barker's fire.

We believe and have said publicly that acts of destruction of American property done by clandestine independentist groups are part of Puerto Rico's struggle for independence.

Q-21 In speaking of revolution, the possibility of revolution in Puerto Rico during the 1970's, would you venture a guess, in terms of probability, how this revolution might occur? Do you think that it would be a rural revolution such as in Cuba or a strong urban revolution such as in Algeria?

It is possible that it does not seem like either the Cuban or the Algerian revolutions in the mechanics of its development. All depends on the reaction of the government and the imperialism to that revolution.

One final question, I think we established that the MPI considered itself an organizing force in the forthcoming revolution and that we secondly established that the acts of terrorism that have gone on in the past were part and parcel of this revolution, does it then follow that the MPI is the organizing force behind these terrorist actions?

No, that conclusion does not follow. MPI is organized to fight with the organization of the masses in a public open front, not a clandestine front. Of course, there are other groups which do carry on this clandestine fight and we recognize that this is part and parcel of the Puerto Rican revolution. We do not monopolize the struggle for independence in Puerto Rico.

As you see it, what is the purpose of this terrorist activity? Do you feel it wins new adherents to the independence movement?

When you talk of terrorism you mean one thing and I another. Terrorism as I understand it, does not attract the masses. However, in a country intervened like Puerto Rico by a foreign imperialist power, action repudiating that intervention tends to lift the conscience of the people and those are factors in the general bringing together of the people for the struggle for independence.

Mr. Mari, you talk about the independence movement being an organization designed to mobilize the masses on an open level. One of the criticisms heard very often against the pro independence movement by other radical independentist groups is precisely the fact that the pro independence movement does not reach the masses; that the pro independence movement, to a large extent, is a middle class movement...."movimiento pro estado" (Statehood movement). What is your feeling about that?

The recent history in the last decade proves that theory is wrong. In an evergoing way and manner, the masses are following the objectives and those points brought out by MPI. It is also proved by the pulse of the people, You can see in the towns of the mining area how the people of the mining area repudiate the mining contracts and you can see also how the people of Culebra are repudiating the intervention of the United States Navy in their own land. All this reflects an awakening of the conscience of the people as a consequence of their radical struggle in Puerto Rico led by the MPI.

Q-25 Mr. Mari Bras, when we were speaking of economics a little while ago, you said that what you wanted was for the Puerto Rican people to go back to the position where they can control the destiny of their own economics. Was there ever a time when they did and when?

No, we have never controlled our economy because Puerto Rico has always been a country intervened by a foreign power and in some measure there has always been a fundamental intervention, therefore, in power in Puerto Rico's economy.

Approximately, how many members does the MPI have?

It is very different to calculate the strength of a political movement at any moment. However, we do have constituency of about 15,000 militants which constitute the nucleus of the movement. This nucleus/surrounded by thousands and thousands of Puerto Ricans who support our objectives and who follow our movement.

If you have thousands and thousands of followers, will that ever move you to take part in the elections?

We do not believe so.

You think you could win an election if you take part?

No, because those elections are administered by a people who administer them to win them and they are not going to give them to us like a trophy.

Mr. Mari, yesterday, Ramon Calderon, the Director of the Civil Defense, stated that there were very strong links between the Popular Democratic Party and the international communism and also very strong links between the Popular Democratic Party and the MPI, do you have any comments?

The only link I can see of the Popular Democratic Party is with the United States imperialism. An imperialism which it serves so well that has facilitated the arrival to power of troglodytes like Calderon.

In regard to the prisoner! exchange that you spoke to us about and the assurances which you received from the North Vietnamese delegation in Paris, yet this was several months ago and nothing hes come through. Do you have any indication that the idea may have run into difficulties between Hanoi and Washington?

There is no doubt that our request may be incontradiction with the present, which we consider correct. policy of North Vietnam to bring the United States to a total solution and not a partial solution of the Vietnam situation. That may be the cause for the delay of our request and evidently, if that is the delay, we accept it very well because we will not accept or try to be an obstacle in the liberation of North Vietnam because Vietnam at this moment represents the vanguard of the liberation forces in the whole world.

Mr. Mari Bras, there are a couple of points. We were talking about elections and your refusal to participate in elections, the way they are held new. Assuming that the revolution was successful and the Puerto Rican nation became a reality, under what form would political force go to the people then, what sort of elections would be held at that time?

We believe that there will be electoral process in the way the republic will be constituted once there is no intervention from foreign powers and we have consolidated the republic of Puerto Rico.

One further point, a few weeks ago, "Claridad" in an editorial statement you tried to separate the death of the young girl student at the UPR and the almost immediately following death of an American

sailor. The death of the girl, you called an act of repression, I believe, and the death of the sailor, you called an effective act of war against the imperialistic powers. Do you consider that a war now exist[petween the MPI and the United States Government?

No, MPI is not in war at this moment with the Government of the United States. But what I said in the article is that there are groups which are at war and that they have the moral right to be at war with the United States Government. MPI is not at war because we have chosen to operate in sight within the legal restrictions of the establishment, however, those who chose to be on the margin of this rather slim legality have the perfect moral right to do it to be at war with the United States.

Would you say that the opposite exists also for the United States Government if a state of war exists it has the perfect moral right to wage war against these groups?

No. I don't believe so because the United States are intruders here and we are in our own country.

Mr. Mari, do you feel the death of the sailor is much more justifiable than the death of the girl from the UPR?

I explain my position at that article which has been more or less summarized by you here.

Q-35 Mr. Mari. getting back to your concept of the Puerto Rican republic, will it be structured more or less the way Cuba is structured now politically and economically?

No. we can develop our republic taking from foreign countries those institutions which are valid for the Puerto Rican realities which are mapplicable. However, the structure of the government of the Republic of Puerto Rico will be peculiar to the identity of Puerto Rico.

Mr. Mari Bras, you have said in the past what I believe is the political position of the pro independence movement, that although foreign capital will be expropriated in Puerto Rico on account of independence, the tapital belonging to the Puerto Rican bourgeoiste would not. In the case of Cuba.Fidel Castro I believe had to take that also. Do you think the time might come when Puerto Rico might find itself in the same position?

Yes, it is possible that in the development of the republic and giving the flux of the national liberation movement we arrive at a moment when the consolidation of certain aspects of our economy would touch into the belongings of the national bourgeoisie.

How do you think that the acceptance of such an act might affect the support which the pro independence movement has among a sizeable amount of wealthy Puerto Ricans or the support of moderately wealthy Puerto Ricans?

We think and so we have expressed in our political thesis, that the social basis for independence will be the working classes, the students, the intellectuals and possibly part of the petite bourgeoisie, but definitely not the big capitalists of Puerto Rico who are intimately related and dependent upon imperialist corporations. That, explains why these capitalists are now the social basis for the statehood forces and not the independence forces.

One thing confuses me, you said that the MPI, unlike some of the subrosa organizations, has chosen to work completely within the framework of the laws as you find them and yet, prior to that, you stated that you really didn't care about the laws when you most definitely violated one when you negotiated with the North Vietnamese. There seems to be a little problem about this.

We operate within the judicial structure but we are not limited by the institutions of the United States. That is, we just obey those laws by a consideration of our relative force. With the people we accept those laws and we have to abide by that which the Puerto Rican people cannot by force violate; but we are willing to violate those laws that the Puerto Rican people is decided upon and capable of violating. An example of this is the draft. We are very conscious of the fact that we are violating the draft law, that we are very willing to violate the United States draft law because the people of Puerto Rico is capable of violating the draft and the United States with all its power is impotent before the people of Puerto Rico in doing anything about our violation of the draft law.

Mr. Mari, is the pro independence group receiving any kind of financial aid from Cuba, Russia or any other socialist country?

No, unfortunately we don't have any financial help from any part of the world.

In your newspaper "Claridad" you frequently quote statements sometimes at great length from . foreign powers, particularly revolutionary powers. Are these statements furnished you directly by the foreign powers or do you receive them second hand?

Governor Ferre has claimed that the terrorists in Puerto Rico are trained in Cuba and other socialist countries. You believe this is true?

Of course not, I do not believe it is true.

What is needed for the development is not funds. That is part of the fetishment of green papers. What is needed is labor which is the main element of the system of production and natural resources. Natural resources we have; we have our land and we have our mineral resources. Those resources and that labor which is produced in great amount in Puerto Rico, the labor, are the key factors of development. The green dollars are only an expression of labor and the mineral resources.

Mr. Mari, if the country does not have any money for example, how would it establish a petrochemical plant which would cost millions of dollars in investment? Can you do it with labor alone? Or with natural resources?

What happens is that you are conditioned by the money psychology which is projected by capitalism. What is needed for a petrochemical industry is not green dollars, it is steel, it is labor, it is parts and it is people to work and put them together.

Mr. Mari, where would the steel come from, if not from dollars?

Among other places, it could come from the iron ore which is stored in Puerto Rico's east and western portions.

Approximately, what percentage of your time do you devote to your activities as Secretary General of the MPI and what percentage to your practice of law?

What I do as a lawyer is minimal. It is somatimes more and sometimes less, but in general I would say that less than 25% of my time is dedicated to the practice of law.

MOVIMIENTO PRO-INDEFENDENCIA DE FUERTO RICO ((FUERTO RICAN INDEFENDENCE MOVEMENT) (MPIFR)

The MPIFR was organized in November, 1939; AV Fonce, Puerto Rico, to work for the independence of Puerto Rico. I' has an envinated membership of between 1,000 and 1,300 people with missions throughout the Island of Puerto Rico and in New York, New York; Chicago, Illinois; and Buffalc, New York.

At the time the MFIPR was organized, it indicated that it did not advocate violence but would accept members who did. AN MARI BRAS, the founder and dominant leader of this organizetion, in a speech during March, 1964, threatened violence comparable what in Algeria, 1964, if Puerto Rico became a costs within the United States. A source reported in 1966 that a leader of the MPIPR has indicated that "the Revolution" would some begin and another source advised that another official of this organization has attempted to obtain a number of automatic pistols.

Articles praising FIDEL CAETRO and the Guban Government regularly appear in the MPIPR publications. In 1951, the MPIPR adopted a resolution expressing a 100 per cent approval of and solidarity with the Cuban revolution. It sent a delegation to the Tri-Continental Conference of African, Asian, and Latic American people, held in Havana, Cuba, during January, 1955, and it maintains a permanent delegate to the Secretariat located in Havana.

The press of Puerto Rico has reported that the MFIPR has held numerous demonstrations protesting compulsory military nervice of Fuerto Ricans and United States policy in Vietnam and the Dominican Republician

In December, 1966, the Governor of Fuerto Rico Signed into law a bill calling for a plebiscite on July 23, 1967, to determine the future political status of Puerto Ricc. The plebiscite, denounced vociferously by the MFIFR as "an act of Yankee imperialism to maintain the colonial status of Fuerto Rico," resulted in an overwhelming endorsement of the present Free Associated State status.

MPLPR -

Resolutions adopted at the 7th National Assently held in late April, 1968, at San Juan, Puerto Rice, included expressions of solidarity with the National Liberation Front of South Vietnam and promises of material support in the form of the solid money. 

CASA DE LAS AMERICAS

On Pay 9, 1969, a source advised that the Casa de las Americas, an organization composed of pro-FIDEL CASTRO and pro-Communist individuals, formed in April, 1964, has its headquarters on the fourth floor, 876 Broadway, New York City. Source described this organization as a successor to the old Casa Cuba Club (CCC) with a changed name to avoid overt affiliation with Cuba. The CCC had been composed of persons belonging to the now defunct 26th of July Movement, a revolutionary organization founded and led by FIDEL CASTRO, Prime Minister of Cuba, until its dissolution in 1962.

A second source advised that the CCC, originally founded as a social club by New York area residents of Cuban extraction, was sympathetic to CASTRO during his struggle for power. Subsequent to January 1, 1959, as it became apparent that Communism was the form of government in Cuba, the leaders of the 26th of July Movement assumed control of CCC and its membership declined.

The first source above advised that Casa de las Americas is also ostensibly formed as a social club, but in effect it acts as a focal point for revolutionary peoples sympathetic to the Cuban povernment. Although it is not directly controlled by the Cuban Mission to the United Nations (CNUN), many Cuban personnel attend its functions and at least an indirect link with CMUN is present. Casa de las Americas has fund-raising affairs and contributes money to the CMUN. Casa de las Americas also gives financial support to other revolutionary groups representing countries other than Cuba. Through CMUN, various propaganda materials of a Communict nature are found at Casa de las Americas. This same source also stated that some executive committee members, as well as general members of Casa de las Americas, are members of the Spanish Section of the Communist Party, United States of America (CP, USA). An indirect link does occur at Casa de las Americas in that it is used as a staging ground prior to entry into CP, USA, Further, source indicates that membership in Casa de las Americas serves as an excellent background for persons desiring to return to Cuba.

This same source stated that, although there exists in Cuba a social club called Casa de las Americas supported by the Cuban government, there appears to be no connection between the two and no reason to believe that the Casa de las Americas in New York was named after the one in Cuba.

Memorandum recommends the Department be requested to furnish opinion as to prosecution in this matter.

Juan Mari Bras, a United States citizen, is a selfemployed attorney who resides in Rio Piedras, Puerto Rico. He is Secretary General of the Movimiento Pro-Independencia de Puerto Rico (Puerto Rican Independence Movement) (MPIPR), largest and often violent proindependence party in Puerto Rico.

On October 30, 1969, Mari Bras publicly announced the North Vietnamese Government was demanding release of five imprisoned Puerto Rican nationalists as part of a proposed prisoner exchange with the United States.

In late December, 1969, news media in France and Puerto Rico announced subject had visited Paris, France, December 26, 1969. According to the French News Service, subject proposed to the North Vietnamese delegation to the Vietnam Peace Conference in Paris an exchange of five Puerto Rican political prisoners for five United States prisoners of war.

On April 21, 1970, subject was interviewed on WTSJ Television in San Juan. He stated, relative to the prisoner exchange proposal, such a request had been made to the Democratic Republic of Vietnam and admitted visiting the North Vietnamese delegation in Paris. According to subject, the proposal was discussed and he stated he received assurances it would be considered by the Government of North Vietnam.

The cause of the crisis was Mari Bras' decision to block publication of a column by Cesar Andreu Iglesias in Claridad no he claimed that the column was a personal attack against him and made public the internal matters of the organization. This action led to the resignations of Andreu Iglesias, Editor Norman Pietri, and Assistant Editor Samuei Aponte from the newspaper. In addition, Andreu Iglesias and Samuel Aponte were joined by Georg. Fromm in resigning from the MPIPP National Mission. Norman Pietri elected to stay in the MPIPP but on Sunday he and Lorenzo fillero and Jaime Luciano arguments they would not accept any position of leadersh', within the MPIPR.

Pietri said in an interview on Monday that although there was a general agreement on the goal of provoking a crisis within the colonial system, there were differences of opinion as to the tactics the Movement should employ in trying to achieve this goal.

Fromm, in his letter of resignation, charged the organization was following a path that was radically different from the fundamental principles outlined in the Political Thesis of the MPIPR and that the directing bodies had been "denaturalized" and converted into "empty: and sterile formalisms". Mari Bras has been openly criticized by some MPIPR leaders who feel he has crossed the line between respectable independentist activity and illegal acts of violence.

San Juan proposed an anonymous letter designed to exploit dissension among MPIPR members as a result of public support of terrorist activity by Mari Bras be sent to selected MPIPR members in San Juan and New York City. San Juan also proposed to send copies of this letter to and and mewspapers published daily in San Juan. Both individuals have previously published articles critical of Mari Bras and the MPIPR. Sending of the proposed letter could create additional dissension and distrust within the MPIPR.







In 1951 the MPIPA adopted a resolution Expressing a 100 per cent approval of the solidarity with the Cuban revolution. It sent a delegation for the Tri-Continental Conference of African, Asian, and Latin American Feople, held in Havana, Cuba, during January, 1966, and it maintains a permanent delegate to the Secretariat located in Havana.

The press of Fuerto Rico has reported that the MFIFA has held numerous demonstrations protesting compulsory military service of Fuerto Ricans and United States policy in Vietnam and the Dominican Republic.

In December, 1965, the Governor of Puerto Rico since into low a bill calling for a plebiscite on July 23, 1967 determine the future political status of Puerto Rico. The plebiscite, demounced vociferously by the MPIPR as "an art of Yankee imperialism to maintain the colonial status of Puerto Rico," resulted in an overwhelming endorsement of the present Free Associated State status.



The posters were being placed on Sixto Escobar Stadium in the Fuerta de Tierra section of San Juan during the course of a MPIPR sponsored demonstration, the purpose of which was to demand free access to all beaches in Puerto Rico.

In the October 7, 1970, edition of "El Diario -La Prensa", a Spanish language newspaper published in New York City, appeared an article entitled, "Things Of Interest". This article states that the MPI will give a press conference today on October 7, 1970, at 12 noon, in Williams Hall at the Overseas Press Club on 40th Street, between Fifth and Sixth Avenues, Manhattan, New York, and that the Attorney Juan Mari Bras of the MPI will speak about the Puerto Rican situation, about Culebra and other topics of interest.

In the October 8, 1970, edition of "El Diario -La Prensa", on page 2, appeared an article and photograph of Juan Mari Bras in the company of several other individuals at a table in the Overseas Press Club. The caption under the photograph states as follows:

"A Standing Fight

"We do not believe in violence, but if we cannot obtain Puerto Rican independence by peaceful means, we will turn to armed revolution", said Attorney Juan Mari Bras, at a press conference, among many other things, yesterday noon, at the Overseas Press Club. At the head table are Sonia Marrero, Isolina Vargas, Attorney Mari Bras, Secretary General of the MPI and Jose Irizarry."

The article entitled, "United States Admits Having "A" Weapons In Puerto Rico:Mari Bras", by Luisa A. Quintero reads as follows:

"Last week, a spokesman for the United States Department of State, testifying before the Senate Foreign Relations Committee in Washington, admitted officially that this nation is utilizing the territory of Puerto Rico for the storage of nuclear armaments. He confessed that such activity is being carried out without having consulted the people. At the same time he exposed the opposition of the United States government to include Puerto Rico in the area covered by the Denuclearization Treaty of Latin America.

"It deals with a crime of perverted humanity. Puerto Rico is a country of little territory and dense population. The presence of nuclear armaments is a risk of life to the entire Puerto Rican nation. This activity is being realized in open violation of international legislation in force, that has prohibited the use of colonial territories for warlike ends, of administrative powers of such territories.

"So was initiated the press conference of Attorney Juan Mari Bras, Secretary Generalof the MPI at the Overseas Press Club in this city at 12 noon.

"Attorney Mari Bras also spoke about the terrible situation in Culebra, owing to the bombings of United States naval-maneuvers. He said that the use of Culebra in such a way, 'constitutes an act of genocide'. He stated that all Puerto Ricans, regardless of differences in political ideology, repudiates this act of the Navy and asks that they remove their naval forces from the island. The fight by Puerto Ricans will remain strong and firm, and they are not ready to concede defeat.

He spoke of the political representation in the Island and of the battle the MPI and other independence groups of Puerto Ricans are waging, 'articulated on a national scale throughout the Island and in the Fuerto Rican population centers in the United States for the independence of Puerto Rico.' He warns, 'the government of the United States that we are waging an unceasing battle until we are rid of the last nuclear armament in our territory. In this fight we will summon the militant solidarity of all peoples, governments, organizations and parties that sympathize with our liberating force:

"There was a question and answer period during the luncheon-conference, which Mari Bras answered, and said that the MPI is in solidarity with the Latin-American Left, positively supporting the election of Salvador Allende in Chile!

"He criticized military recruitment and said that Puerto Ricans would not join the military nor would they go to fight. He said that 'agriculture has been ruined in the last six or seven years and gave as an example the sugar crop, that has decreased from 1,200,000 to 40,000 tons in the last harvesting; that unemployment is near 30 per cent despite official figures of 16 per cent; that Puerto Rico had exported coffee, and now has to import it; and that they will resist Northamerican exploitation of copper mines!.

"He praised the militant attitude of the Young Lords Pary, (YLP), with which he is in complete solidarity. He insisted that the MPI 'does not want war of violence, but is ready to fight for independence in any form that may be necessary!"

In the October 13, 1970, edition of "El Diario - La Prensa", on page 6 appeared a photograph of a number of people listening, according to the caption, to an informal talk by Juan Mari Bras, at Columbia University (CU) on Saturday, October 10, 1970.

Appearing beneath the photograph was an article entitled, "The Movement For Puerto Rican Independence Should Be a Sister To Socialism: Mari Bras". This article reads as follows:

"The MPI Should Be a Sister To Socialisam: Mari Brester



"The Secretary General of the MPI Juan Mari Bras, said yesterday in this city that the fight for independence of the 'Island', should become a sister to Socialism just as much in New York City as it is in Puerto Rico.

"Mari Bras added that 'We are struggling for a radical transformation of all oppressions...the placing of contemporary man in the essential conflict-the fight of the oppressed against the oppressors, the battle of the exploited against the expoliters '.

"The MPI leader made these manifestations at an informal talk held at Columbia University concerning 'the political situation of Puerto Rico '.

"Mari Bras indicated that 'Puerto Ricans are one race, one nation...one nationality that by virtue of strange happenings has dispersed more than half of them throughout the world...nevertheless, the geographic dispersion has not destroyed the social values represented by this nationality... The objective of securing the survival of this nationality is to obtain independence...!

"Without independence the existance of a nationality is in peril and denies the great mass of the governed to have a motherland'.

"The MPI leader who spoke before some 300 students indicated: 'to have a motherland is to be situated in life facing the Universe. Man cannot live without the ties of the motherland...Motherland is the first autonomically social institution...without motherland man would lose himself in the universe. Love of country is what distinguishes man from beast!.

"He added that 'the struggle for liberation of Puerto Rico will liberate as much in New York as in Puerto Rico .

"Mari Bras declared solemnly: 'The Puerto Rican living in New York has the right to maintain his language, his customs, his culture, that is within itself the right to maintain love of country '."

On October 14, 1970, the first source made available a mimeographed throwaway which disclosed that Juan Mari Bras; Secretary General of the MPI would lecture on the political problems of the Puerto Rican nation and its struggle for independence at 7:00 pm on October 10, 1970, at the Horace Mann Auditorium, Teachers College, CU under the auspices of the MPI-NYM.

On October 15, 1970, the first source advised that on October 10, 1970, the MPI-NYM sponsored a lecture by Juan Mari Bras at the Horace Mann Auditorium, Teachers College, CU, 120th Street and Broadway, New York, New York, concerning the contribution of the Puerto Ricans in the United States to the struggle for national liberation and social change in the United States.


The first source furnished the following information regarding Juan Mari Bras' activity while in New York City in October, 1970:

On October 2, 1970, Juan Mari Bras was the feautured speaker at a conference sponsored by the MPI-NYM at the CPR. Mari Bras spoke for approximately two hours on such topics as the "Grito De Lares" celebration in Puerto Rico, the recent presidential election in Chile and guerilla fighting in several South American countries.

On October 9, 1970. Mari Bras attended a concert featuring Roy Brown Ramirez, a young Puerto Rican singer of protest songs and a film presentation of the recent "Grito De Lares" activities in New York City, sponsored by the MPI-NYM at the CPR.

On October 10, 1970, Mari Bras was present at a small celebration given in his honor by members of the MPI-NYM at 1878 Harrison Avenue, Bronx, New York.

On October 11, 1970, Mari Bras was present at general membership meeting of the MPI-NYM at the CPR.



On October 5, 1970, the first source advised that Mari Bras was scheduled to speak at <u>Princeton University</u> on October 5, 1970, and at City College of New York, on October 8, 1970, however, source was unable to state whether or not these engagements were fulfilled.

On October 12, 1970, the first source advised that Mari Bras departed New York City at 6:00 pm on October 11, 1970, enroute to Puerto Rico, by air.

YOUNG LORDS PARTY

In an article appearing in "The New York Times," December 30, 1969, page 30, PABLO GUZMAN, also known as Yoruba, then Deputy Minister of Information for the Young Lords Organization (YLO) in New York, stated the YLO was composed of revolutionaries, was one with the Cuban revolution, desired a socialist society, and independence for Puerto Rico.

According to a source, YORUBA spoke at C. W. Post College, Greenvale, New York, on March 5, 1970. In the speech, YORUBA delivered a scathing attack on all whites and declared that "from now on" the black and Puerto Rican brothers will unite against "the pigs." He pledged an organized campaign of violence and singled out Jews and white liberals as the main enemy "of our people."

A second source advised that the YLO is composed mostly of Puerto Rican youths and originated as an organization at Chicago, Illinois. The YLO is based on the philosophy of MAO Tse-tung and HO Chi-minh, with Marxist-Leninist ideology.

The Young Lords Party (YLP), according to a statement read over its radio program, "Palante," on station WBAI-FM on May 25, 1970, declared itself autonomous from the YLO National in Chicago, with a National Headquarters then located at 1678 Madison Avenue, New York, New York. According to this statement, the YLO in New York was first formed in July, 1969, as the New York State Chapter of the YLO and subsequently received a degree of autonomy as the YLO-East Coast Region. The split was attributed to a lack of political leadership on the part of the YLO National in Chicago.





In the "General Statement" adopted at the 14th Annual FUPI Congress which was held at Rio Piedras on.~ November 18 - 20, 1969, and dedicated to HO CHI MINH, the deceased political and ideological leader of North Vietnam, FUPI declared that the common enemy of all countries is Yankee imperialism; proclaimed that the final victory - on a universal scale - against imperialism can only be achieved. with the united struggle of all the oppressed in the world ; and that the spinal chord of that struggle is the armed people; greeted and expressed their-solidarity with the "neroic -Vietnamese people, vanguard of the anti-imperialist struggle"; greeted and expressed their solidarity with the comrades who await trial for refusing to join the American army and with the university students who will be tried-after the radical struggle against the Reserve Officers' Training Corps (ROTC); and resolved to continue supporting and strengthening the Organizacion. Continental Latinoamericana de Estudiantes (Continental Organization of Latin American Students) (OCLAE) because it is the only student organization on a continental level which is giving moral and material support to the Latin American revolutionary.

MPIPR

The MPIPR was organized in November, 1959, at Ponce, Fuerto Rico, to work for the independence of Puerto Rico. It has an estimated membership of between 1,000 and 1,300 people with missions throughout the Island of Puerto Rico and in New York, New York; Chicago, Illinois; and Buffalo, New York.

At the time the MPIPR was organized, it indicated Livet it did not advocate violence but would accept members who ild. JUAN MARI BRAS, the founder and dominant leader of this organization, in a speech during March, 1964, threatened violence domparable to that in Algeria, 1964, if Puerto Rico became a state within the United States. A source reported in 1966 that a leader of the MPIPR has indicated that "the Revolution" would soon begin and another source advised that another official of this organization has attempted to obtain a number of automatic pistols.

Articles praising FIDEL CASTRO and the Cuban Government regularly appear in the MPIPR publications. In 1961 the MPIPR adopted a resolution expressing a 100 per cent approval of and solidarity with the Cuban revolution. It sent a delegation to the Tri-Continental Conference of African, Asian, and Latin American People, held in Havana, Cuba, during January, 1966, and it maintains a permanent delegate to the Secretariat located in Havana.

The press of Puerto Rico has reported that the MPIPR has held numerous demonstrations protesting compulsory military service of Puerto Ricans and United States policy in Vietnam and the Dominican Republic.

In December, 1966, the Governor of Puerto Rico signed into law a bill calling for a plebiscite on July 23, 1967, to determine the future political status of Puerto Rico. The plebiscite, denounced vociferously by the MPIPR as "an act of Verkee imperialism to maintain the colonial status of Puerto Rico, vertited in an overwhelming endorsement of the present Free forceiated State status.

The latter activity was held approximately one mile from the main gate of the Roosevelt Roads Naval Station. The demonstration consisted of the participants bearing placards, walking in a circle, and chanting, "Puerto Ricans-Yes, Yankees No," and "Yankees Go Home."

The demonstration concluded at 3:35 p.m. following a short talk by Juan Mari Bras, the Secretary General of the MPIPR, condeming the presence of atomic bombs in Puerto Rico, and the singing of the Puerto Rican National Anthem.

The demonstration was followed and controlled by the Police of Puerto Rico, and no incidents or violence occurred. No arrests were made.







The November 3, 1970, edition of "El Imparcial," a Spanish language newspaper published in San Juan, Puerto Rico, indicated that Jose Milton Soltero departed for Chile with a group of individuals, including Juan Mari Bras and Ruben Berrios, to attend the inauguration of Marxist president Salvador Allende.

On November 9, 1970, SJ T-3 advised that Prensa Intina, Santiago, Chile, issued a broadcast indicating that on November 7, 1970, Chilean president Salvador Allende received Members of the Puerto Rico delegation, which attended his inauguration. This delegation consisted of Ruben Berrios Soltero, and Manuel Maidonado Denis. During the meeting, the Puerto Ricans expressed their desire for increased rapport other things. They had previously expressed the same desire to Chilean Foreign Minister Clodomiro Almeyda.

"Carta Semanal," weekly publication of the Movimiento Pro-Independencia de Puerto Rico (Puerto kican Independence McVement)(MPIPR), in its issue of March 30, 1966, ennounced the formation of a committee to raise funds for the defense of SIXTO ALVELO, "the first MPIPE rember to pit his patriotic dignity against Yankee imperialist brutality..." The May 31, 1966 issue of "El Imparcial," a Sparish Committee for the Defense of Sixto Alvelo, and that it had declared its apposition to obligatory military service for Puerto Rican youth.

The September 3, 1967, issue of "The San JuanStar," English language daily newspaper, reports that the Conmittee for the Defense of Sixto Alvelo was taking over the defense of nine local youths charged with Selective Service violations. The September 4, 1967, issue of "El Imparcial" reports the same news but identifies the organization as the Comite Sixto Alvelo Pro Defensa de la Juventud.

The January 20, 1970, issue of "El Imparcial" contained a report on the 4th Annual Assembly of the Alvelo Committee for the Leienze of Puerto Rican Youth and included among the resolutions passed at the assembly one which read, "to struggle for the Defense of Puerto Rico and to join in efforts with all Pro-Independence organizations and movements in Puerto Rico, opposing compulsory military service." Elected at this assembly as President of the organization was Dr. HECTOR DAVILA ALONSO.

In the January 25, 1970, issue of "Claridad," weekly hewspaper published by the MPIPR, a report appeared on the 4th Anone: Assembly of the Alvelo Committee with the observation the results demonstrate the Alvelo Committee has clearly of 1sd itelf with the cause for independence of Puerto Rico. JUAN MARI BRAS, the founder and dominant leader of the organization, in a speech in 1954, threatened violence comparable to that in Algeria, 1954, if Puerto Rico became a state within the United States.

MARI BRAS, in an editorial appearing in the March 15, 1970, issue of "Claridad," the MFIPR newspaper, stated that "in Puerto Rico there is an incipient armed struggle on the part of pro-independence individuals who consider it their patriotic duty to conduct warfare against the empire which dominates us. We believe that every Puerto Rican has the right to make war against the jimveders of our country. And war is mainly killing and dying."

The press of Puerto Rico has reported that MPIPR has held numerous public meetings and demonstrations at which they protested compulsory military service for Puerto Ricans and United States police in Vietnam. The MPIPR has further urged the boycott of elections in Puerto Rico.

On April 21, 1970, during the course of a program on WTSJ Television in San Juan, Puerto Rico, MARI BRAS stated that the MPIPR has innumerable contacts with revolutionary organizations in South America, Canada, Cuba, Europe, Africa, and in Asia. Through 1969, the MPIPR had a permanent representative stationed in Havana, Cuba. GROUPS SEEKING INDEPENDENCE FOR_PUERTO RICO

The MP was founded in 1948, but has declined in votes drawleadly since 1952. The party first lost legal standing when it sailed to pull the required five percent of the total vote cast. in the elections of 1960. The PfP was placed on the ballot by legislative edict for the 1964 elections, but again failed to poll the required number of votes. After being placed on the 1966 while the fulfilling all legal requirements for recognition as a publicate party by petition, the PfP received less that three percent of the total vote cast, again losing its status as a registered party.

Un March 10, 1970, Mrs. ROSITA M. CORDOVA, Secretary to the Euperintendent, Commonwealth of Puerto Rico Elections Board, advised that at the January 23, 1970, meeting of the Elections Board the FIF was certified as a legally constituted political party in Fuerto Fico by reason of petition.

Ine January 26, 1970, edition of "The San Juan Star," an English language daily newspaper published at San Juan, Puerto Rico, reported that during his speech, accepting the presidency of the PIP, RUBEN BERRIOS MARTINEZ pledged himself to a more radical politient posture, with "Christian socialism" and "pacific militance" as principal tactics. In an interview, BERRIOS placed special significate on the inclusion of other means of gaining independence in adultion to going to the polls, such as more active participation in protests, marches, pickets and boycotts.

The February 24, 1970, edition of "The San Juan Star," reports that BERRIOS stated that "The only way to solve.". the problem of military occupation in Puerto Rico is to achieve our independence as a nation."

The April 17, 1970, edition of "El Mundo," a Spanish language daily newspaper published at San Juan, Puerto Rico, contains parts of a speech given by BERRIOS wherein he says that the members of his or phisation are to intensify the struggle against the regime, but that violence was ruled out for his party. He added that the regime, ore proficable for their cause to let the invaders break the regime. Some day," he stated, "the lackeys of Yankee imperialism fill go of the far and there will be innocent victims and blood will un."
